they have selected me to be part of a show a reality based show about home construction and renovation making homes new again re-working the sand and board of their original construction into something new and valuable i am working together with a demon from hell and we are building a new house out of dirt and nest the demon i work with is not tall or strong but he has the power of deception and illusion we work each day together and apart i am about the size of a small car but i look very different and i behave very different i see the world in a unique way my name is Jason i did not choose this name

but it is something i live with each day i have not had many jobs but i do not let that stop me if there ever is a day of sunshine and i do not open my window has it been a day wasted i do not know before the world was anything it was wet and dark and without product and it has been long since then and now and for as long as i can remember i have always wanted to start a company to occupy professional space i imagine the first animal to emerge from the wet how did it think it crawled and goo'd and became me and this is what I am doing now

i am a dancer at the Olympics a timeless and evil ceremony the world watches my body () i am dancing for the first time i am not yet good but everyone can enjoy what i am doing and see a part of themselves in my movements i am nude without cloth but i am covered in dirt and moss the dance is long as the world disco something begins starting to grow a little thing it grows inside my as the world discovers me something begins it grows inside my tummy making me so big it comes out my lower half looking new and beautiful looking like a puffy worm

an innocent sentience with beautiful face everyone at the olympics all people at the auditorium the Micheal Jackson memorial auditorium love my new little creature everyone receives one kiss all is forgiven

chanting eternal clown frequency 10 hour long YouTube video only softly interrupted by respectful ads for truly useful and ethical products i fear our world has become ridiculous but the self must remain boiled down into small cube or orb **o** of pure and true humanity **C** which i choose to believe **U** has the possibility to exist inside within each person - even if they really seem like absolute piece of shit or bastard what does everyone think they are trying to do here we hope for health and longevity and hope for help to see the world as we did before

not with disgust but with novelty they should have a clown for president clown also running central bank but they will not they are cowards
